Council Meeting Synopsis:

March 8, 2011: Lift Station #2 for the wastewater system was again on the agenda. An update on the current status of the lift station and repairs to one of the pumps was given along with a revised estimate. Following discussion on the lift station the council discussed two insurance policies the Village had been carrying, one for the council and one for the police department. These two policies had been packaged with the Village's overall insurance policy in the past. With the change in carriers these policies were now stand-alone policies. The two policies provided coverage above and beyond what was necessary so the council decided to cancel the policies and realize a significant cost savings.

A review of the Village Code of Ordinances was begun at this meeting. The council reviewed three chapters, Chapter 6-Alcoholic Beverages, Chapter 10-Amusement Devices, and Chapter 14-Animals. The council decided that the first two ordinances were ok.

The review of Chapter 14-Animals received the large part of the time. The council heard about requests and questions that the Village had received regarding this ordinance. The three biggest are the number of dogs permitted, stricter regulation of cats, and whether or not chickens were permitted.

The council decided to spend time gathering public opinion on potential changes before starting a reworking of the ordinance. This decision to gather opinion at this time is an attempt to get the residents involved earlier in the ordinance process. This is in response to comments received in the past that it feels like the decisions have been made before public opinion is sought.

March 22, 2011: The council was given an update on the repairs to the pump from Lift Station #2. Damage to the pump was more extensive than originally known but work is progressing. An update on the Farm to Food Farmers Market grant as well. The Village has received a positive letter from the Michigan State Historic Preservation Office so we can now complete the environmental review.

The council reviewed three chapters of the Village code of ordinances. These chapters included Chapter 19-Bicycles and Other Wheeled Vehicles, Chapter 26-Burning, Open, and Chapter 37-Compost Site. This review is part of a systematic review of the entire code.

Representatives of Fun Services were present to inform the council of vandalism to their building and share their thoughts on the incident.

Bellevue Community School Board, Bellevue Township, and Village of Bellevue Joint Meeting:

The Bellevue Community Schools, Bellevue Township, and the Village of Bellevue will be holding a joint meeting on Wednesday, April 20, 2011. This meeting will begin at 7:00 p.m. and be held at the Bellevue High School Media Center (library).

This meeting, as all government meetings, is open to the public and we encourage members of the community to attend.

Flushing Water Mains:

The Village will be flushing water mains on Wednesday, April 20 and Thursday, April 21. Water may be discolored during this time.



Village of Bellevue Code of Ordinance Review

The Bellevue Village Council is currently reviewing the Village's Code of Ordinances. They are reviewing chapters for any necessary or desired modifications. As part of this review they will be considering feedback or requests that have been received in the past regarding specific chapters or issues. The review is being completed at council meetings with specific chapters being placed on the meeting agenda.

The council would like to encourage community residents to share their opinions on the Village's ordinances. If there is a change, addition, or deletion you would like to see now is the time to share that. You can share your ideas or opinions in several ways:

The most recent chapter the council is looking for feedback on is Chapter 14-Animals. Based on feedback that has been received the council is considering changes to this chapter, specifically in the number of dogs allowed to be kept and the type of animals allowed to be kept. Please share with us your opinion on increasing the number of dogs, as well as your feelings about allowing chickens to be raised inside the village limits.

on S. Williams St. next to Keehne Environmental Area just north of the railroad track

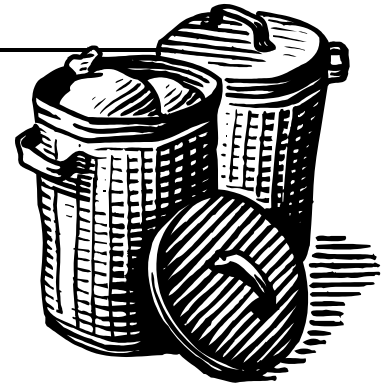
Open to the entire Bellevue community, township and village residents. There will be charges for certain items and portions of the event. Please refer below for these costs.

Any items dropped off before or after the appropriate date and times of this event will be considered littering and subject to all fines and prosecution this entails.

List of Items Accepted:

Rubbish & Junk

Bellevue Township and the Village of Bellevue will have dumpsters located at the site. This service will be free for Bellevue Township and Village of Bellevue residents. You must have some form of identification available as proof of residency. If you are not a Bellevue Township or Village of Bellevue resident then you may drop off items for a fee. The fee shall be \$50.00 per pick up load with a minimum charge of \$50.00. These dumpsters will be for rubbish and junk. Items that will not be accepted are: roofing shingles, organic material, yard waste (grass, leaves, brush, stumps, etc.), liquid wastes (paint, oil, chemicals, etc.), hazardous waste, concrete, rocks, dirt, or rubble.



Scrap Metal



A scrap metal pick up will be part of the spring clean up. This pick up will accept all types of scrap metal at no charge, except as noted here, including cars, trucks, aluminum, farm machinery, snowmobiles, clean barrels (no liquid or residue such as gas or oil may be in the barrel), propane tanks (there will be a \$5.00 charge for propane tanks), appliances, and Freon containing appliances and devices such as refrigerators, air conditioners, and freezers (there will be a \$20.00 charge for Freon containing items). Car batteries will also be accepted. If you have a larger item such as a car, truck, or farm machinery that you wish picked up you may contact Dennis Lapoint Sr. at 269-209-3170 or Dennis Lapoint Jr. at 517-719-3644.

A portion of the proceeds from the Scrap Metal will go to the Bellevue Wrestling program.

Automobile & Light Truck Tires Recycling

There will be a tire pick up held by Bellevue Area Wide Antique Engine & Machinery Show. They will accept Automobile & Light Truck Tires (less than 16.5"). There will be a nominal fee of \$4.00 per tire for the drop off.
