The council discussed when stumps will be ground around the village, and N. Roberts is checking with M. Bassett but believes it is once yearly. B. Balkema would like us to look at putting a few digital speed limit signs into the budget for next year. N. Roberts told the council that she contacted the bus garage about changing the school drop-off and pick-up to something other than Jefferson Park while the road is closed and under construction.

D. Swartz moved to adjourn the meeting at 8:13 p.m., seconded by B. Balkema. Motion carried.
