Andrew Rudd from Wightman updated the council on the Phase II Wastewater Plant Project and the projected award for the grant funding.

The council reviewed the Election Ordinance, and the Village Officers hold four-year terms, not two-year terms as stated in the General Law Handbook.

N. Roberts will send the proposed Kids Place easement from Riverwood Mobile Home Park to our attorney for review. The proposal to use East St. is on hold until the easement is voted on.

The council discussed compensation for certificates and licenses that employees earn before being hired by the Village. They are also discussing a pay scale based on both longevity and position.

The council decided to move the first meeting in November from the 11th, Veterans Day, to the 12th.

The council discussed various methods for the Village to contact residents in the event of an emergency. We currently contact six television stations, seven radio stations, and post on our website. Depending on the type of emergency, we will also contact businesses that serve drinks and food. N. Roberts stated that the Village can use the Eaton County texting system; residents would need to opt in to participate. E. Bird stated that the school system would be willing to allow the Village to use their messaging/email system if needed. N. Roberts is also exploring the possibility of establishing a Village Facebook page that is separate from an employee's personal information.
