S. Roberts moved to give all Village Employees the cost of living raise of 8.7% on January 1st, 2023 with wages to be reviewed again before June 2023, seconded by R. Spaulding. Motion carried with Roll call vote: S. Roberts, R. Miller, D. Miller, Spaulding, B. Balkema – Ayes. R. Miller – Nay.

S. Roberts moved to keep the water/sewer rates at \$11.95 per gallon with a base rate of \$48.00 for sewer and \$4.35 per gallon with a base rate of \$24.00 per gallon, seconded by R. Miller. Motion carried with a Roll call vote: S. Roberts, B. Balkema, R. Miller, D. Miller, R. Spaulding – Ayes.

Discussed Village 2023 budget, will be moved to the next meeting.

S. Roberts moved to renew the Village Manager 2023 contract with N. Roberts, seconded by R. Spaulding. Motion carried with Roll call vote: S. Roberts, B. Balkema, R. Miller, D. Miller, R. Spaulding – Ayes.
