B. Balkema moved to approve the “Agreement to Provide Services” from the Bellevue Fire Control Board for a three-year term, with an annual amount of \$105,000, payable in quarterly installments of \$26,250, seconded by E. Bird. Roll call vote: H. Coy, S. Roberts, B. Balkema, J. Willis, L. Pfiester, E. Bird – Yeas. Motion carried.

H. Coy offered a resolution to approve the application and participation in the Eaton County Parks Community Grant Program for improvements to Jefferson Park and to appoint N. Roberts as the official signee of any grant-related paperwork, seconded by B. Balkema. Roll call vote: H. Coy, S. Roberts, B. Balkema, J. Willis, L. Pfiester, E. Bird – Yeas. Motion carried.

It was decided to table the Discussion on the Water Main on S. Williams St. until April 8, 2025, when Wightman can be present to answer additional questions. The fire department asked if they could borrow the Village’s fireworks mortar/shooters for the 4th of July. They will not need us to transport them. The council said that the fire department can borrow them.

H. Coy moved to adjourn the meeting at 8:30 p.m., seconded by B. Balkema. Motion carried.
